LICENSING & REGISTRATIONS

Ownership and Lease Changes - No Longer Backdated

Effective immediately, NZTR will no longer backdate ownership or lease changes subsequent to a horse having raced.

- If the relevant documentation is completed and submitted prior to a horse racing, the transaction will be processed accordingly.
- However, backdating ownership or lease details after a horse has raced breaches the New Zealand Rules of Racing, which may render the transaction invalid and illegal.
- Such changes can also create financial discrepancies, exposing NZTR to potential liability and administrative complications.

This approach aligns with our commitment to regulatory integrity and financial accuracy.

Stud Book Follow-Up: Stallion and Foal Registrations

The Stud Book team is actively following up on:

- Late 2025 Stallion Registrations
- 2024 Foals that have not yet been:
 - Branded
 - Microchipped
 - DNA tested

We appreciate your attention to these requirements and encourage early completion to avoid delays in processing.

GST Zero-Rated Purchases and Racing Eligibility

We have identified an issue involving horses purchased through Gavelhouse under zero-rated GST status, which were subsequently entered to race. This practice is inconsistent with GST conditions and racing eligibility.

- Gavelhouse has been advised of NZTR's ability to block horses purchased under zero-rating from racing until compliance is verified.
- This practice was previously applied only by New Zealand Bloodstock (NZB), but will now be extended to Gavelhouse sales moving forward.

All participants are reminded to ensure the correct GST status is applied when purchasing horses intended to race.

- Please ensure all stable and owner colours are renewed promptly to avoid lapses in registration.

 - Holding an active licence is a requirement to participate in the industry.

TRACKS & INFRASTRUCTURE

Taupo Track Widening

The Track Widening project at Taupo Racecourse has been completed. The track width has almost doubled in size at some points around the track and cambers have been improved. The Return to Racing protocols have been completed following the work. Track gallops were held successfully before 12 heats of restricted trials were run on Monday 4th August. Comments from riders were all very complimentary of the track and what had been achieved, especially with the home bend. Taupo race on Sunday 17 August.

Riccarton Irrigation project

Progress at Riccarton is steady. Recent milestones include completion of pipe trenching and installation works for a majority of the racecourse; Backfill and compaction has been completed for several portions across Course Proper; The Bore – mechanical installation is complete; and, Electrical connections have been finalised for multiple bore pumps. Next week will see the completion of the tank liner, and some hardware installation and pressure testing.

Otaki Irrigation

Irrigation experts have been looking into upgrading the Otaki irrigation system. Some inefficiencies of the system were exposed last year during an investigation following an abandoned race meeting. This project is in very early design stages.

Te Rapa Irrigation

Work under the Steeplechase course at the Northern end of the track and the 1600m chute has been largely completed. The next stage of work, trenching inside the rail, will commence after Waikato Stud Foxbridge Plate Day on 23 August.

TRACKS & INFRASTRUCTURE

Awapuni

Horses were galloped on the course proper 22 July. Following those gallops and after an assessment of the track, it was agreed that the Club can proceed to Restricted Trials on the 12th August. Track adviser Liam O'Keeffe and the RIB will continue to be involved in the decision making process. The main focus for the Track Team at Awapuni is grass growth and density. The cooler weather and heavy frosts have made growing difficult. Progress and future plans are being closely monitored by Living Turf.NZTR have purchased a new Redexim verti-core 2100, based at the Awapuni venue. This will be available for all Clubs to use during their annual renovation.

Regional Track Advisers 2025/2026 Season

NZTR has announced some changes to its Regional Track Adviser (RTA) Programme for the 2025-26 racing season. Jason Fulford, Bart Cowan, Alan Chapman and Wayne Stevens will all continue as RTA's and will be joined by Colin Cromarty (Waverley) and Jamie Phillips (Trentham). The RTA's will be supported by highly regarded Flemington Racecourse Manager, Liam O'Keeffe, as a specialist consultant.

Hawkes Bay Update

Liam O'Keeffe will undertake Turf Testing on his next visit in August with recambering scheduled to begin in September as previously planned to return the current Hastings Venue to racing by Spring Carnival 2026.

RACING OPERATIONS

Jumps Season Update

Below is a short summary of some key metrics from the jumps season to date including Riccarton Day 1:

- 11 Race Meetings
- 41 Jumps Races
- 25 Hurdles 16 Maiden, 9 Open
- 16 Steeplechases 7 Maiden, 9 Open
- 9.15 Average Field Size

At the conclusion of the jumps season NZTR will provide a full breakdown of key statistics and commentary against previous years.

RSDF reminder

As per previous seasons, Clubs are invited to apply for funding for the first round of the 2024/25 Racing Safety Development Fund, with \$990,000 (GST exclusive) available for distribution over two rounds.

Applications to the Fund can be made through the Department of Internal Affairs' online system and need to be completed and submitted by no later than 17 September 2025.

Please note that priority will also be given to projects supported by their Code or RIB, so please contact NZTR's Head of Tracks and Infrastructure, Tim Lambert, with your proposed project plan.

Saddlecloth Pockets

NZTR is working with TripleS to gather data on the number of saddlecloth pockets required for each Club. Once this is confirmed NZTR will order the pockets in bulk from Hyland Sportswear and arrange shipping to each Club. It is the responsibility of each Club to have the pockets sewed on correctly to their saddlecloths, and to coordinate pockets for sponsor saddlecloths shared between Clubs.

RACING OPERATIONS

TripleS Sectional Timing: Project Update

NZTR has received the following project update from TripleS on the roll out of sectional timing.

We are currently finalising preparatory steps and expect to have our team on the ground within the next two weeks to get going on the groundwork, starting North and making our way down South. Before deployment, we will be reaching out directly to each club to coordinate and ensure that the proposed timeline aligns with their schedules and availability.

Looking ahead, we are targeting October 1st as the start date for final installation and live testing across all participating clubs. Again, we will work from North to South but are currently looking into getting a second operational team to speed up the process. We remain committed to keeping all involved stakeholders informed and ensuring a smooth and coordinated rollout.

Camera Towers Safety Review Reminders

Scissor Lift Specifications and Approval

If the towers at your Club have been deemed not fit for use, your Club is required to provide a temporary structure (e.g. scissor lifts) until remedial works or replacements are completed. For the avoidance of doubt, please find the required minimum specification <u>here</u>.

Temporary structures must be approved by NZTR, Entain, and the RIB at least 14 days before your next race day.

Remedial Works and Replacements

The same approval process of a minimum of 14 days' notice applies to any remedial work being done to make existing towers safe to use again. Evidence of this work will be shared with Goleman Group for sign off.

If your Club plans to replace a tower that can't be repaired, the new structure must also be formally approved by NZTR, Entain, and the RIB.

Note - funding for remedial works and replacements can be applied for under the RSDF.

WELFARE

Equine Crematorium Now Operational

In addition to providing a dignified end for our horses, the Equine Crematorium facility will also offer learning opportunities for veterinarians via Massey University. Postmortem facilities will allow continuing work in the area of understanding the contributing factors of fatalities which can be complex. The findings of these studies will be used to then recommend measures that may mitigate future risk.

Equine Crematorium and Logistics for training, trial and race fatalities

To support this work, we have partnered with Animal Burials to ensure the respectful and timely collection of horses in the event of a fatality. Richard Logan (027 497 6058) is your direct contact for on-track collections. Richard has asked that you contact him immediately when an incident occurs to enable him to respond promptly. The quoted cost for collection ranges depending on location. For the upcoming season, we will fund 50% of the transport cost and fully cover the cost of cremation.

Equine Mortality Review Panel

The Equine Mortality Review Panel has been established to review any death associated with a race day within 72 hours. Where possible, post-mortems are conducted to determine whether identifiable factors contributed to the incident. However, to ensure a consistent and comprehensive approach, we are now extending this commitment to include training and trial fatalities that occur in public training facilities North of Taupo from 1 August.

The goal is to collect and review every fatality to identify any contributing factors, recommend preventative measures, and educate stakeholders about risk mitigation. The circumstances leading to an equine fatality are often complex and multifactorial—by gathering data in a structured, respectful, and thorough manner, we can support the health and safety of future generations of racehorses.

Raceday Fatalities

For the 2024-25 season we have recorded 15 raceday fatalities In the 2023-24 season there were 18 fatalities and 14 in the 2022-23 season.

WELFARE

On-Track Incident Preparedness and Post-Fatality Protocols

Before the start of each race meeting, a brief coordination meeting should be held involving all key personnel responsible for the running of the event. This ensures that in the event of a serious incident or fatality, there is a clear and coordinated response plan. It is essential that stewards, veterinarians, track staff, and emergency responders understand their individual roles and responsibilities in such situations.

Our Horse Ambulance drivers continue to provide outstanding support in managing these situations, and we are fortunate to have access to such a professional and compassionate service.

A designated area should be identified in advance for the secure and respectful placement of any deceased horse. This location must be discreet, out of public view, and allow the horse to be appropriately covered until collection. Ideally, Animal Burials will collect the horse at the conclusion of the race meeting, ensuring minimal disruption to the event while maintaining the highest standard of care and respect.

Now that the Equine Crematorium is fully functional, any race, trial, or training incident occurring at a public facility will be collected. This allows us to ensure consistency in post-incident processes, uphold high welfare standards, and maintain respect and dignity for the horse involved.

We acknowledge that conversations with owners in these circumstances can be sensitive. However, it is the responsible and ethical course of action. By collecting this information, we not only honor the horses involved but also contribute to research that will inform future welfare strategies and better protect at-risk horses. KEY REMINDERS AS AT 12 AUGUST 2025

INCORPORATED SOCIETIES ACT 2022 - RE-REGISTRATION REMINDER

We would like to remind all clubs to take action to comply with the new legal requirements under the Incorporated Societies Act 2022 (Act) as soon as possible.

- Has your club reviewed and updated its constitution?
- Have you submitted it to NZTR for approval?
- Re-registration is essential to maintain your club's legal status.

Are you eligible for Compliance Funding??

NZTR has incorporated compliance funding into the Funding Policy to support clubs meet the new legal requirements under the Act. To be eligible your club must:

- Have its updated constitution approved by NZTR by Friday 29th August 2025.
- Successfully re-registered with Companies Office by Friday 30th January 2026.

Why do Clubs need to Re-registration Urgently?

Legal Protection and Continuity

Maintains your club's legal status, allowing it to continue to operate smoothly. Protects committee members and officers by safeguarding them from personal liability.

Access to Funding and Grants

Keeps your club eligible for funding and grant opportunities to support the clubs activities and growth.

Assets and liabilities

Ensures that clubs can continue to own property, enter into contracts and lease agreements.

Provides certainty for ongoing financial and operational commitments.

Future-Proofing Your Club

If a club fails to re-register within the specified timeframe, it will be removed from the Incorporated Societies Register.





INCORPORATED SOCIETIES ACT 2022 – RE-REGISTRATION REMINDER

WHAT EACH RACING CLUB NEEDS TO DO:

Review and update the Constitution

- NZTR together with Morrison Partners, previously provided clubs with guidance on the re-registration process, including compliance requirements, checklists, and template documents.
- Consider seeking independent legal advice if required.

Seek NZTR approval for the new Constitution or any amendments

- Under the Racing Industry Act 2020, NZTR must approve all club constitutions or amendments prior to having legal effect. We recommend seeking NZTR's approval prior to clubs AGM or SGM where these constitutions or amendments will be voted on.
- Approve the new constitution or amendments at the AGM or SGM Club meeting
- Organise an Annual General Meeting (AGM) or Special General Meeting (SGM) to discuss and vote on the new constitution or amendments

Complete the re-registration process through the Companies Office website

KEY REMINDERS AS AT 12 AUGUST 2025

SECTIONAL DATA (TRACK MARKERS - RED)

NZTR has invested heavily in providing sectional times and data for interested parties. In order to produce accurate information, we ask that all clubs have red markers clearly displayed at the 200, 400, 600 and 800 metre marks and also 400m after the start of each start point (i.e. for a 1600m race there needs to be one at the 1800m)

EQUINE FATALITIES IN TRAINING

To enable NZTR's proper equine welfare reporting, clubs are required to notify NZTR when a horse dies or is euthanised as a result of a training incident. lease advise training-name.

RACEDAY BOX CONTAMINATION

Due to the risk that horses may swab positive for human drugs, NZTR reminds Clubs that they should:

- Regularly replace sawdust and straw in boxes which are used on race day; and
- Advise both through signage and race day security that participants must not urinate in horse boxes.

OPTIONS FOR REPORTING BULLYING AND HARASSMENT ISSUES

NZTR emphasises that there are avenues available for any participants who feel they have been badly treated to report their concerns and have them addressed.

Industry participants can be assured that the NZTR Board and management have zero tolerance for sexual harassment and bullying in the industry. Fair and respectful treatment of all participants is a fundamental expectation for involvement in our sport.

The industry, in partnership with the Salvation Army, employs two full-time welfare support staff, who are available to discuss any personal issues, and complaints can be made to any NZTR staff member.

The complaints will be taken seriously, with the priority being the rights and wishes of the complainants.

Participants can also directly contact the Racing Integrity Board, through the racing integrity line, with the option of leaving their contact details or an anonymous message.



NEW ZEALAND THOROUGHBRED OWNERS FEDERATION

RIB Advisories

The RIB has recently issued two advisories, summarised below and linked in headings in full for reference. It would be useful if this is communicated to club's local trainers and a printed copy of each displayed in the trainers' hut (if applicable).

• RIB Contamination Prevention Advisory (August 2025)

This provides trainers with clear guidance on minimising the risk of prohibited substance contamination through responsible medication use, good stable management, hygiene protocols, and staff awareness. It outlines best practices for treatment procedures, record-keeping, feed sourcing, and environmental controls to help avoid inadvertent breaches and support equine welfare.

• RIB Use of Sedatives Advisory (July 2025)

This advisory outlines the veterinary, safety and regulatory considerations associated with administering sedatives to horses during routine ridden work. It emphasises that such use should only occur under strict veterinary justification, with full documentation, and warns of potential risks to rider safety, diminished training efficacy, and compliance with the Rules of Racing and New Zealand health and safety laws.
